- 3. The Citizen's Charter is positioned at the main entrance of the office or at the most conspicuous place of all the said service offices.
- 4. The Citizen's Charter is written in English and published as an information material.
- 5. The Citizen's Charter is uploaded in the agency's website and accessible to the public.
- 6. The Citizen's Charter was first published on *November 2012* and underwent review and revision on *January 8, 2015* as required under Section 4, Rule IV of the IRR: *The office or agency shall review the Citizen's Charter whenever necessary, but not less than once every two years.*
- 7. The Citizen's Charter already shows the improvements that resulted from the process review of frontline service delivery, specifically:
  - created facility for online customer satisfaction feedback survey; and
  - automated required reports in the Project Management Information System (PMIS) for easy respond to our clients/partners
