



BAC RESOLUTION NO. 2019-007

DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF CONSULTING SERVICES FOR THE FORMULATION OF ROADMAP AND ACTION PLAN FOR THE INDUSTRIAL TECHNOLOGY SECTORS OF PCIEERD

WHEREAS, on 31 January 2019 and in accordance with Section 7 of IRR of RA 9184, upon recommendation of the Bids and Awards Committee (BAC), Executive Director Enrico C. Paringit, as Head of the Procuring Entity (HOPE) of Philippines Council for Industry, Energy and Emerging Technology Research and Development (PCIEERD), approved the 2019 Annual Procurement Plan (APP), which includes the above-mentioned project;

WHEREAS, on 06 June 2019, the Purchase Request (PR) No. GAA-19-3347 amounting to Four Million Pesos (Php 4,000,000.00) was approved;

WHEREAS, on 05 August 2019 and mandated by Section 20 of IRR of RA 9184, a Pre-Procurement Conference for the Procurement of Consulting Services for the Formulation of Roadmap and Action Plan for the Industrial Technology Sectors of PCIEERD was conducted with the presence of the end user representatives and the BAC members;

WHEREAS, on 10 August 2019 and mandated by Section 21 of IRR of RA 9184, the BAC, through its Secretariat, posted the Request for Expression of Interest for the Procurement of Consulting Services for the Formulation of Roadmap and Action Plan for the Industrial Technology Sectors of PCIEERD on Philippine Government Electronic Procurement System (PhilGEPS), website of PCIEERD and at conspicuous places within the premises of Department of Science and Technology (DOST) and PCIEERD;

WHEREAS, when the deadline for submission of bids lapsed on 19 August 2019, 9:00 A.M., no bid/eligibility documents was received;

WHEREAS, under Section 35.1 (a) of the IRR of RA 9184, the BAC shall declare the bidding a failure when no bids were received;


NOW, THEREFORE, WE, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare a failure of bidding for the Procurement of Consulting Services for the Formulation of Roadmap and Action Plan for the Industrial Technology Sectors of PCIEERD and re-post the opportunity for public bidding.
