The committee shall have the following functions but not limited to:

1. Ensure that PCIEERD satisfies the eligibility criteria for PBB to include:
  - a. Good Governance Conditions;
  - b. Performance Targets;
  - c. Performance Ratings of Employees and CES Positions
  - d. Other Cross-cutting Requirements
2. Ensure the timely submission of reports and requirements for compliance to PBB guidelines
3. Strengthen the communication strategy to ensure transparency and accountability in the implementation of the PBB;
4. Coordinate with monitoring agencies such as the DBM, CSC, IATAF and AO 25 Secretariat among others.
5. Create Technical Working Groups (TWG) if necessary to assist in the compliance of requirements of PBB.
6. Submit semi-annual accomplishments to the PCIEERD Development Committee (PDC) relative to Committee functions.

This Special Order shall take effect immediately, supersedes all issuances inconsistent herewith and shall remain in force for a period of one (1) year from the date subject to annual review and renewal.
