



***Section 1. Request for Expression of Interest for Consultancy Services  
For the formulation of Roadmap and Sectoral Plan  
For Emerging Technologies of the following Sectors:***

- 1. Advanced Materials and Nanotechnology***
- 2. Information and Communications  
Technology (IoT, AI and Data Science)***
- 3. Photonics***
- 4. Space Technology Applications***
- 5. Convergence of Emerging Technologies  
Towards Industry 4.0***


1. The Philippine Council for Industry, Energy and Emerging Technology Research and Development (PCIEERD), through the General Appropriation Act 2018 intends to apply the sum of **Php 7,000,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract for "PROCUREMENT OF CONSULTANCY SERVICE FOR THE FORMULATION OF ROADMAP AND SECTORAL PLAN FOR EMERGING TECHNOLOGIES OF THE ABOVEMENTONED SECTORS". Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The Philippine Council for Industry, Energy and Emerging Technology Research and Development (PCIEERD), now calls for the submission of eligibility documents for procurement of consultancy services for the formulation of roadmap and sectoral plan for emerging technologies. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before December 4, 2018, 9:00 a.m. at PCIEERD Conference Room, 5<sup>th</sup> Floor Science Heritage Building. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. Interested bidders may obtain further information from PCIEERD and inspect the Bidding Documents at the address given below during office hour at 8:00 A.M. to 5:00p.m.
4. A complete set of Bidding Documents may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the amount of Php 7,000.00 for the Bidding Documents not later than the submission of their bids.

The interested Bidders may acquire the said Bidding Documents on November 27 to December 19, 2018 from the address below.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of *three (3)* prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:
  1. *Track Record of the Application (50%)*
  2. *Staff Expertise/Qualifications/Team Composition (25%)*
  3. *Job Capacity/Absorptive Capacity (25%)*
6. The Philippine Council for Industry, Energy and Emerging Technology Research and Development will hold a **Pre-Bid Conference on December 7, 2018, 9:00 a.m. at OED Meeting Rm., 5<sup>th</sup> floor Science Heritage Building** which shall be open to shortlisted bidders/consultants.
7. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
8. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)*. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals]. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
9. The contract shall be completed within six (6) months.
10. The PCIEERD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
